Federal COVID 19 Funds

Federal CARES Act

- Coronavirus Relief Fund
 - \$800 million to local units with populations > 500,000
 - \$3.1 billion to the state for the following:
 - Necessary expenditures incurred because of the COVID-19 public health emergency;
 - Costs not accounted for in the most recently approved State budget as of the date of enactment; and,
 - Costs incurred between March 1, 2020, and December 30, 2020.
 - Asking for retroactive flexibility to backfill revenue reductions

Other Federal COVID 19 Funds

- Others
 - Transit Programs
 - Community Development Block Grants
 - Community Services Block Grants
 - Federally Qualified Health Centers
 - Food and Nutrition Supports
 - Housing and Homelessness Supports
 - Low Income Home Energy Assistance
 - Election Security
 - Byrne Justice Grants

FEMA Public Assistance Grant Program

- State, local, tribal and territorial governments and certain private nonprofits are eligible applicants.
- Emergency Protective Measures are the eligible cost category for FEMA PAGP.
- All potential applicants should register with the federal Grants Portal by April 30, 2020.

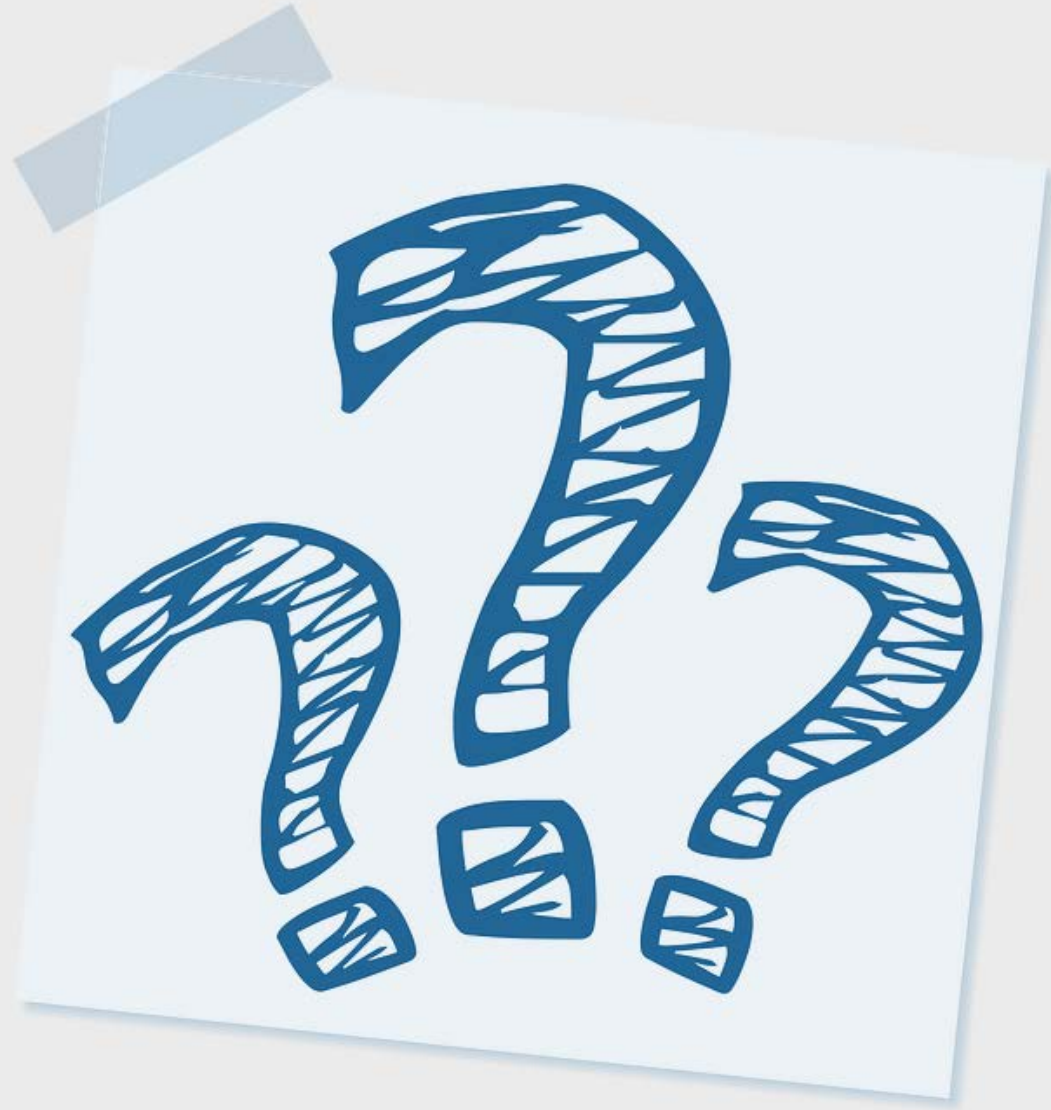


Key Actions to Take Now
