



4/20/2020 Update Banks that are SBA Approved to Accept PPP Applications

As you know, currently the PPP has exhausted its funds. Congress is working to come to agreement on adding funds to that program.

If you did not apply before that happened and plan to if funds are added please check this list of who we know are approved lending institutions for the PPP. If your bank is not listed, please confer directly with your bank to determine capability.

We are also hearing from banks, that you are better off to go to a bank you already have a relationship with to apply for PPP if at all possible as they are under the “know your customer” rules and your application will process faster than if you have to go to a bank that doesn’t know you. There are 4 lenders listed at the bottom of this list that do not require an existing customer relationship to file a PPP.

Banks are also recommending that you have copies of your 2019 tax returns, documentation of payroll for 2019 and payroll YTD for 2020 at a minimum. Obviously this is all subject to change. Please check with your lender on their specific process.
